1 Introduction

1.1 A word from the Management Board

Even though at first sight trading statistics appear to reveal subdued investment activity, the year 2015 will be remembered by several events of exceptional significance for the local and regional capital market.

It opened with a listing of Tankerska Next Generation d.d. shares in the Official Market segment of the Zagreb Stock Exchange – the first such new post-IPO listing since 2008. March saw the admission to trading in the same Exchange's market segment of Granolio d.d., with Ilirija d.d. and Luka Rijeka d.d. passing to the Official Market following a capital increase. Indicating certain changes in investment trends and turning to the capital market as a source of financing, those were important highlights for the Exchange itself and the market in general.

Given that surveillance systems are an important component of exchange operations aimed at identifying and preventing manipulative trading patterns and market abuse, the Zagreb Stock Exchange has strengthened its technology infrastructure by implementing a new system to surveil all trading segments – regulated market, multilateral trading facility and OTC market. It has also added a new functionality to its website, enabling companies with plans for initial public offerings or those which have already embarked on the process to publish related content online via dedicated issuer pages on the Exchange's website.

In April, the international Regulatory Oversight Committee authorised the status of Local Operating Unit to the Zagreb Stock Exchange, so it began assigning and administering Legal Entity Identifiers (LEI) in May as the first organisation in Croatia and immediate region to provide to market participants this service of vital importance for global financial stability.

The ZSE Academy, an educational unit of the Zagreb Stock Exchange founded with support of the European Bank for Reconstruction and Development (EBRD), marked the fifth anniversary of its work in May. More than 4 000 individuals have attended various forms of education provided by the Academy, which has organised more than 240 events, as well as the first certified programme for investor relations managers – unique in Croatia and the region – now seeing its third generation of participants. Having delivered training to 2 000+ higher education and secondary school participants, the Academy has won the Prijatelj Studenata (Friend to Students) award, given by the eStudent association to the organisations which contribute to the quality of student life, for two years running. It concluded a cooperation agreement with the Croatian Employers' Association in a joint effort to raise the level of financial literacy both among the general public and entrepreneurs, and presented diplomas to the second generation of certified investor relations managers. In mid-March, the Academy launched a string of activities marking the World and European Money Week – a global event designed to raise awareness of the importance of financial literacy among the young population, involving some three million children and young people around the world.

In May, Zagreb was the venue of the second joint Zagreb and Ljubljana Stock Exchange's Investment Day, at which seven Croatian and six Slovenian issuers were presented to investors. Featuring 24 investment companies and banks and 48 analysts and investors, who made a total of 175 requests for meetings or 25% more than a year earlier, the event resulted in as many as 142 one-on-one meetings and group conferences in the course of a single day.

In June, the Croatian Financial Services Supervisory Agency, the Central Depository and Clearing Company and the Zagreb Stock Exchange held their sixth round of education for the companies with shares listed on the Exchange's regulated market which gathered 120 representatives of listed companies.

October saw the Zagreb Stock Exchange and fund industry conference with almost 400 participants and 40 speakers, making it the most successful one to date.

The fourth Zagreb Stock Exchange Awards, founded in 2012 with the aim of honouring the best financial market participants in terms of both objective, statistical criteria, as well as their overall contribution to education and the development of the local capital market, were presented in December. Its laureates included the telecommunications operator Hrvatski Telekom d.d. as the most heavily traded stock and confectioner Kraš d.d. as the top performer in the highest price growth category, while investment company Intercapital Vrijednosni Papiri d.o.o. was declared the Exchange's member firm of the year. The ZSE Academy's award for outstanding contribution to capital market education went to the Ekonomska Klinika student association of the Faculty of Economics and Business in Zagreb, with Tankerska Next Generation d.d. company as the recipient of the award for outstanding contribution to capital

market development. Valamar Riviera d.d. recorded the greatest increase in turnover and was also voted Stock of the Year by the public.

The SEE LINK project of regional trading integration initiated by the Zagreb, Bulgarian and Macedonian Stock Exchange, which got a new website in 2015, entered its final stage.

However, the year will be remembered primarily for the Exchange's successful capital increase, ushering the EBRD into its ownership structure, and by the acquisition of the Ljubljana Stock Exchange which confirms the role of the Zagreb Stock Exchange as a pioneer of consolidation processes in the region.

Despite a continually challenging environment, the Zagreb Stock Exchange has managed to initiate and implement several major projects of vital importance for the future of both the local and regional capital market. In doing so, it has not only maintained but also improved service quality in a bid to meet the requirements of shareholders, investors, issuers, member firms and all stakeholders.

1.2 Zagreb Stock Exchange in 2015.

The 2015 trading statistics were marked by a decline in order book trading turnover by approximately 10% (-11.5% in shares, -9% overall). However, the activity itself may be described as quite lively, taking into account an increase in the total order book trading volume by 50%.

The CROBEX inex experienced a 3.2% correction, while the average for the ten most liquid stocks stated by the CROBEX10 recorded a slightly better result (-1.8%). The performance of the CROBEXindustrija (+6%) and CROBEXturist (+23,7%) indices testifies to some solid investment opportunities and, in view of the peaks tested in the course of 2015, all the indices have traded above their end-2014 levels.

As market capitalisation grew 3.3% overall, the most significant expansion occurred in the structured products segment (+180%), but with continued concentration in a small number of shares: the five largest accounted for approximately half of the market value while the five shares with the largest free float capitalisation represented 44% of the total market capitalisation.

Hrvatski Telekom d.d. (Croatian Telecom Inc.), accounting for 15% of the total turnover, was the most liquid share in 2015 once again (in 2014 it had a 23% share in the turnover), with the five most actively traded (HT-R-A, ADRS-P-A, RIVP-R-A, PODR-R-A i ADRS-R-A) representing 46% of the turnover.




Chart 1: Orderbook turnover (mil HRK)




Chart 1: Zagreb Stock Exchange equity index CROBEX®




Chart 2: Zagreb Stock Exchange equity index CROBEXtr®




Chart 3: Zagreb Stock Exchange equity index CROBEX10®




Chart 4: Zagreb Stock Exchange equity index CROBEXplus®




Chart 5: Zagreb Stock Exchange bond index CROBIS®




Chart 6: Zagreb Stock Exchange bond index CROBIStr®




Chart 7: Sectors with the highest Market Capitalization




Chart 8: Sectors with the highest Turnover




Chart 9: Market Capitalization structure




Chart 10: Free Float Market Capitalization structure




Chart 11: Structure of equity turnover
